Bids opened

Two bids for motor fuel tax work in Rossville were opened Wednesday.

Dan Ribbe Construction of Bismarck submitted a bid of \$23,998.87, and McCalman Construction of Danville bid \$24,574.50.

Trustees will decide which bid to accept at their Aug. 21 meeting.

Motor fuel tax work includes street and alley repairs in the village.

Man held

A Hoopeston man is being held in the Vermilion County jail on \$50,000 bond stemming from charges of aggravated unlawful restraint, aggravated battery and unlawful use of a weapon.

Roland M. Wilson III, 25, of 623 E. Thompson, was charged Monday following his arrest Saturday.

Wilson allegedly detained a man at gunpoint in the 300 block of Front St.

He is scheduled to appear in court Aug. 31.

Sentencing set

Charles Allison, 44, of rural Rossville, is to be sentenced Oct. 13 in federal court.

Allison pleaded guilty Monday to attempting to possess a mixture or substance containing cocaine with intent to deliver.

Allison, who was arrested May 2, faces up to 20 years in prison and more than \$1 million in fines.

Filing bankruptcy may not be answer to financial woes

We live in confusing times here in Hoopeston. Sometimes it looks like the industrial base is about to collapse and sometimes things look like they are improving (for example, Schumacher's huge expansion).

Nonetheless, these ups and downs can have a dramatic effect on budgets. You get a raise and buy a new home only to find out your plant is closing.

In the old days, if you did not pay your debts, you could be jailed or sent to a "poor farm" to work off your debt. Bankruptcy reform changed

all that.

Bankruptcy is intended to be a second chance; however it is not entirely. In today's society, you often need credit to buy a car, appliance or home. Bankruptcy will stay on your credit report for ten years (it used to be seven). During that time, getting credit will be troublesome. Is this all bad?

Not really. Face it. When you owe everyone money and can pay no one, your credit is already ruined and no bank or business will extend you credit anyway. Because you cannot file bankruptcy again for many years and after bankrupt you owe fewer creditors money, your chances of getting credit may actually be better.

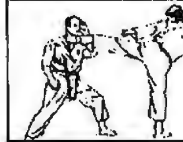
