Rossville board to pay for 50,000 brochure reprints

ROSSVILLE—Trustees will pay for 50,000 copies of a promotional brochure for the village, but will do so grudgingly.

At Monday's board meeting, trustees approved a \$2,957 bid from Craftsman Printing. Hoopeston, for copies of 50,000 brochures. The brochures will be distributed by the Illinois Department of Tourism, as well as local merchants.

Work on the original brochure, organized by former trustee Sherry Ray, "was a major hassle," said trustee Mick Braddock. "There were a lot of hard feelings."

Braddock alluded to dissension between the village's two merchant groups, the Rossville Merchants Association and the newer Progressiver Merchants Association. "There were problems with all sides making up one mind on it," Braddock said.

Trustee Richard Kiser, acting as mayor for the vacationing Merv Smith, said the village "is not in the position...to do the advertising for the vil-See REPRINTS on other side

Job loss leads to new business for Hoopeston woman

Good things can come disguised as problems, as Joyce Allen knows.

Allen, an FMC employee for more than 20 years, lost her job with the company in January. Losing her job was "probably one of the luckiest breaks that's ever happened to me because now I can get on with my life."

One way Allen is getting on with her life is by starting a new business venture.

Customers will find familiar faces at Allen's office. Ruth Drollinger and Heidi Crouch, employed by Drollinger, will now work for Allen. "Other than location, everything's pretty much the same," she said.

The new venture is right for Allen, who admits she enjoys number crunching. "I love it," she said. "I even dream numbers."
