

Rural man threatens residents

A rural Hoopeston man remains in the Public Safety Building in Danville after he allegedly threatened people with a gun.

Apolinar Solis, 34, of 38836N 1830 East Rd., Hoopeston, was arrested at 7:03 p.m. Saturday, charged with aggravated assault, unlawful use of a weapon, arson and intimidation.

According to reports, Hoopeston police and a Vermilion County sheriff's deputy responded to Baer's Trailer Court where Solis was allegedly threatening people with a handgun.

Solis allegedly fled and was located at a relative's home near Heaton Elevator on county road 1900 East.

Solis was arrested and taken to the police department, where he allegedly tried to set unidentified material on fire. He was later taken to the Public Safety Building.

Police are investigating a hit and run accident at 1 a.m. Saturday.



Stephen Compton, 520 W. Main, reported Saturday that someone threw eggs at his 1993 Ford and at his home. The amount of damage done is unknown.


