Lawyer warns against will kits for listing final wishes

Some are; some aren't. Most people are not aware, however, that the document itself is only part of the legalities making a will valid. As important as the will itself are the laws and procedures pertaining to wills.

There are many formalities and requirements for a will to be valid. For example, most will kits have a place for two witnesses to sign, but many

people would not know that a person who is to receive a gift through the will is not a proper wit-

> The laws pertaining to wills should be thoroughly understood by the person drafting it. For example, it is not proper to disinherit a child by simply leaving him or her out of your will. You must specifically state your inten-

tion to disinherit the child.

Likewise, there are "magic words" that should be in wills which impact dramatically on the distribution of your estate after your death. If your estate is distributed "per capita" and a child dies before you, her share will be divided among her brothers and sisters. If it divided "per stirpes"

then that child's share would go to her descendents, not necessarily to her siblings.

Remember: if there is one flaw in the will itself or in the execution of the will, in all likelihood, it will be thrown out by the court. If it is thrown out, the deceased person's wishes cannot even be told

to the judge and the estate will be divided among surviving relatives.

A lawyer spends at least an entire semester learning the intricacies of wills and estates. Will kits are risky and given the fact that wills are one of the most inexpensive things lawyers do for their clients, you are far better off to pay and have your will done correctly.
