# **Excess flood money rains on Grant Food Cupboard**

The Grant Township Food Cupboard is reaping some good from the 1994 flood.

The Food Cupboard has received a \$1,000 check from the East Central Illinois Community Action Agency in Danville, said Grant Township supervisor Carol Flint.

The money was part of the Midwest Flood Relief block grant from the Department of Commerce and Community Affairs.

The block grant was used to help flood victims

who applied for assistance. The remaining money is being given to food pantries in Vermilion and Iroquois counties which were affected by the flood.

Grant Township officials opened the program to "people who'd never used the Food Cupboard," Flint said. "That's why we're one of the food cupboards singled out to receive money."



Flint said, adding that although the money is "wonderful...," it will "just meet the daily needs of the Food Cupboard."

Cuts in the federal commodities program means the Food Cupboard depends even more on donations from local businesses, organizations and residents, especially during this time of the year. "It's the time of year when things get kind of low anyway," Flint said.
