Challenger seek school board seats in Hoopeston, Milford

Voters in two of three local school districts will have a choice today at the polls.

In Hoopeston, incumbents Ed Layden Jr. faces a challenge from Contessa Wilson. Incumbent Gary Jett and challengers Deborah Catron, Roger Bundy, Stephen Unger, James Klaber and Sharon Roark are running for the other two available seats.

Incumbent Robert Hatfield did not seek re-election.

For the Milford Grade School board, Incumbent Roger Francis and newcomers Steve Benner and Mike Boyd are running for three seats.

Incumbents Marvin Andris and Larry Pate did not seek re-election.

In the Milford High School district, incumbents Nick Adsit, Steve Rapp and Robert Rogers are being challenged by Dawn Sexton and Cheryl Smith.

In Rossville, incumbents Don Frazier, Tony Zarate and William Matthews are running unopposed.

and Saturday in the high school auditorium.


