### State's attorney clears revolving loan group of alleged

Charges will not be filed against, nor changes made by, Hoopeston's revolving loan committee.

The committee was under investigation for allegedly violating the Illinois Open Meetings Act during a portion of an April 1 meeting closed to the public and press.

The Hoopeston *Chronicle* contacted Vermilion County State's Attorney Michael Clary after the meeting, alleging the committee violated the Illinois Open Meetings Act when it went into executive session to discuss the finances of a revolving loan applicant.

But in a May 20 letter to Mayor Bob Ault, Clary said he will not take action against the committee,

saying the group "was doing its best to satisfy the conflicting requirements of the Open Meetings Act and the Small Business Development Act," which requires financial information of applicants for Department of Commerce and Community Affairs grants be kept confidential.

"It's a triumph of common sense over frivolity," said alderman Bill Goodwine, revolving loan committee chairman. "I feel it's a total vindication."

Revolving loan funds originated when Schumacher Electric repaid a DCCA loan. The money has since

### Danville man leads local police agencies on 12-hour chase

A Danville man was being held in the Iroquois County jail Wednesday after being hunted by local police agencies for almost 12 hours.

Aaron Dobyne, 26, of 934 Belton, Danville, was arrested in a cornfield near Milford shortly after 10 a.m. Wednesday.

The hunt for Dobyne began when he was stopped by Rossville police at 11:26 p.m. Tuesday, approximately one mile north of Rossville on Route 1. After the officer took his license to run a wanted check, Dobyne allegedly fled in his car, heading north on Route 1.

Hoopeston police tried to intercept Dobyne, but he turned from Route 1 onto Lovers Lane Rd, then north on Sixth Ave.

Police said Dobyne drove his vehicle around a squad car set up as a road block, then re-entered Sixth Ave. He then allegedly hit an eastbound vehicle on Route 9.

The driver of that vehicle, Amy Tyler, of Hoopeston, was taken to Hoopeston Community Memorial Hospital for treatment.

Dobyne then allegedly left the scene on foot. Hoopeston and Rossville officers, as well as a Vermilion County K-9 unit, searched the south side of Hoopeston, but Dobyne was not seen until Wednesday morning, when Iroquois County police were notified of a suspicious person in the ditch near the rest area south of Milford on Route 1.

When Illinois State Police at Ashkum and Iroquois County sheriff's deputies went to the area, Dobyne allegedly ran into the cornfield where he was arrested.

Dobyne was wanted on a Vermilion County warrant for failure to appear. He is also facing preliminary charges of aggravated reckless driving, aggravated fleeing and eluding, leaving the scene of a personal injury accident, speeding and improper

been reloaned to local businesses who were turned down by financial institutions.

Clary conceded that there are no provisions in the Open Meetings Act for "allowing a governmental body to go into executive session when considering matters which are required by another state or federal statute to be kept confidential." He has requested an opinion from the Illinois Attorney General, but said he is unsure when the opinion will be given.

Until the Illinois Attorney General's office

responds, Clary suggested that loan applications be reviewed administratively, using city employees, rather than elected officials, to review applications.

That strategy would pose problems because the city does not have enough employees who could review applications, Goodwine said. "I don't really understand (the administrative solution), but it doesn't appear to work for us."

Also, Goodwine said, having one or two

employees review applications might give the appearance that only applicants in the good graces of reviewers would be approved. "That would be a terrible disservice to those two people," he said.

For those reasons, Goodwine said, the committee will make no changes unless the Attorney General issues a conflicting opinion or the Open Meetings Act is changed. "I suspect the law will be changed," he added.
