County treasurer reports on April investments, interest

Vermilion County treasurer Sue Stine reported that for April 1996, the county has \$17,215,165.73 invested in time deposits and U.S. Treasury bonds earning between 4.53 and 9.1 percent. Investments are based on competitive bidding among interested banks. The total of all money held by the treasurer is \$22,380,034.34. Funds invested locally include Community Bank of Hoopeston, \$454,855.64, Kankakee Federal Savings (Hoopeston branch) \$100,000 and First National Bank of Rossville, \$101,795.23. Palmer American National Bank, including the Hoopeston branch, has a total of \$2,973,969.92. Investments at other institutions include: First National

Bank of Danville, \$1,469,570.91; First Midwest, \$4,386,916.75; Allerton State Bank, \$101,836.11; First National Bank of Catlin, \$1,102,859.37; First National Bank of Fairmount, \$151,981.25; First National Bank of Georgetown, \$107,658.95; First National Bank of Ogden, \$1,281,771.66; and First National Bank of Westville, \$101,794.17. Also, First of America, \$101,525.99; First Ridge Farm State Bank, \$4,247,611.29; Oakwood State Bank, \$1,003,188.74; Sidell State Bank, \$102,663.46; and U.S. Treasury bonds, \$4,592,034.89. Investment information is available from the treasurer from 8 a.m. to 4:30 p.m. Monday through Friday.

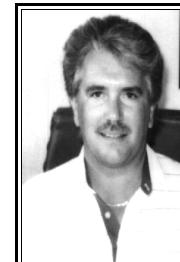
