## Local restaurateur shows signs of displeasure with insurer

"If they could take my premiums,

they should pay my claim"

Alit "Joe" Jusufi is unhappy with his property insurance provider and is letting everyone know it.

An Aug. 28 fire destroyed Jusufi's original Hoopeston Family Restaurant at 224 W. Penn. Jusufi reopened the restaurant earlier this year at 728 W. Penn.

Nearly 10 months after the fire, Jusufi's insurer, Milwaukee Insurance, has not paid Jusufi's claim.

Late last week, Jusufi let everyone know of his displeasure when he erected two signs at the original building reading "Milwaukee

Insurance doesn't pay their claims."

"They shouldn't be allowed to do this," Jusufi said. "If they could take my premiums, they should pay my claim."

Milwaukee Insurance representatives could not be reached for comment, but local insurance agents not affiliated with the claim say the delay is caused by an unresolved investigation into the blaze.

Investigators from the Bureau of Alcohol, Tobacco and Firearms ruled the fire arson, but said Jusufi cooperated with investigators and was not considered a suspect.

in connection with the fire, which is still under investigation, said Victor Herbert, resident agent in charge of the Springfield ATF office. Herbert would not comment on who is a suspect

No arrests have been made

in the case.

A local insurance agent, who is not connected to the case and who requested anonymity, said insurance companies "don't have to prove that an individual started a fire. When arson's involved, it's like 'You prove you didn't do it. That's just the way the law is written."

## Indiana man nabbed locally gets 175-year prison sentence

A Renssalaer, Ind. man was sentenced last week to 175 years in prison for the August shooting deaths of his parents and grandmother in Gary, Ind.

Ronald M. Berry, was convicted last month of killing his family members.

Berry was arrested Aug. 19 in Hoopeston by local police officer Roger Beaty and Sheriff's Deputy Mary Wright.

Beaty answered a call to Jerry's IGA on Routes 1 and 9 concerning a suspicious person in the bushes. Beaty found Berry, who told Beaty he had had a motorcycle accident outside Hoopeston.

Wright was called in to help search for the

motorcycle, which was never found.

When officers searched Berry, they found a 9mm gun with laser sights in a backpack the suspect was carrying.

While Wright transported Berry to the county jail, Beaty was notified by Gary police that Berry was wanted as a suspect in the slayings.

While Gary police suspected Berry, local officers finding the gun helped seal his conviction.

The judge who sentenced Berry said that although he could not impose the death penalty, he wanted Berry to serve a long sentence.

Berry is not eligible for parole under the sentence.
