#### Labor group withdraws request for local police bargaining unit

Hoopeston police officers will not be represented by a bargaining unit.

A petition to organize the Hoopeston Police Department, was withdrawn by the Policemen's Benevolent Labor Committee on June 4, said Mayor Bob Ault.

The Benevolent filed its original petition on April 4.

Ault said the petition was withdrawn after the Benevolent discovered the city does not have enough full-time employees to meet the criteria for establishing a union.

For police to join the group, the city had to have a minimum of 35 full-time employees among all municipal departments. Hoopeston has 32 such employees, Ault said, adding some of those would

have been disqualified because they are department supervisors.

Benevolent representatives examined city employment records before withdrawing their petition, Ault said. "I think they looked at the facts and said 'Why waste our time," he said.

A hearing on the request was scheduled last month, but was postponed until June 10-11. On May 31, however, the Benevolent requested continuance to June 27 or July 11 before withdrawing the petition.

Eric Poertner of the Benevolent, who worked with local officers, did not return telephone calls and could not be reached for comment.

Officers had hoped the Benevolent would help negotiate better salaries and an additional officer to the nine-man department.




