Three injured when car drives through local restaurant wall

Three people were treated for injuries received Friday when a car drove through a wall at the Shell Mart/Burger King, Routes 1 and 9.
Marcile Chestnut, and a passenger in her vehicle, Mildred Langdoc, along with Marilyn Jorgenson, a Burger King customer, were all treated and released from Hoopeston Community Memorial Hospital.
Chestnut, 77, of 502 W. Maple, told police that she was southbound in the parking lot when her Chevrolet Caprice jumped the sidewalk and went through the wall.
Chestnut's car struck two unoccupied tables, pushing them into a table where Jorgenson was seated with two grandchildren.
The grandchildren got away from the table, but Jorgenson was hit in the elbow by flying glass, according to police reports.
Chestnut was ticketed for failure to reduce speed to avoid an accident.
Approximately one quarter of the dining area's northern wall was damaged. A damage estimate was not available at press time.
Burger King was closed for approximately an hour while employees cleaned up glass and other debris.
Within two hours, local contractors had constructed a new wall and the restaurant was
