Drama students to present play in memory of cast mates

Some Hoopeston Area High School students will honor the memory of two of their fellow students by allowing the show to go on.

Students will present "Get Smart" in memory of Doug Layden and Andrea Epps who died in an Oct. 31 car accident, said drama club sponsor Rita Tolch.

The play was to have been presented last weekend but was cancelled after the accident. Mr. Layden and Miss Epps were both cast members.

The memorial performances will be at 7:30 p.m. Nov. 15 and 16 in the high school auditorium. Admission will be free. However, Tolch said donations will be accepted for a memorial fund for

the two students.

Although the district did not establish a memorial fund, "a number of people have sent checks to the school," Tolch said.

All money donated will be "put together to do something special and significant" in memory of Mr. Layden and Miss Epps, Told said.

Drama club members were given the choice of whether to reschedule the play and how to recast the roles. Tolch said she and another teacher, Mike Caparula, will read Miss Epps' and Mr. Layden's lines.

Three hurt in four-vehicle accident


