Vermilion County Board changes to night time meetings

DANVILLE—Night time is the right time for the Vermilion County Board.

The board voted 13-10 on Tuesday to move its meetings to evening for a six-month trial basis.

One board member abstained from the vote and three members were absent Tuesday.

The group now meets at 9:30 a.m. on the second Tuesday of each month.

Proponents of the change said night meetings would allow more input from county residents, but opponents, including local District 1 representatives, disagree.

The district's three representatives - Tim Drollinger, Gary Weinard and Jack McQuigg - all voted against the change.

"The board felt it was in everybody's best interests to move meetings to improve participation," Drollinger

The meeting change will begin in January and will be re-evaluated in July. "To me, they picked the worst time to do it, when it gets dark early and with the snow," Drollinger said. "They should have picked summertime."

Drollinger, a member of the county's personnel committee, said the change will cost the county more in overtime. "You've got people who have to attend the meetings and the county is going to have to pay them." he said.


