### Hoopeston Area board sets up road rules for info superhighway

Hoopeston Area High School students who travel the information superhighway now have rules of the road, thanks to the district school board.

At Thursday's meeting, the board approved an acceptable use policy to go along with the school's recent ability to access the Internet.

The policy forbids students from sending or displaying offensive messages or pictures, using obscene language, vilating copyright work and using thenetwork for commercial purposes.

Students are also asked not to misrepresent their ages or make unauthorized copies of software or information and holds the school not responsible for material accessed by students.

The Hoopeston Public Library is once again helping the Grant Township Food Cupboard.



No gifts will be exchanged, but hot dogs and barbecue will be served and Dave Barker of Maui Club will provide music.



because it provides its own special education services and because it spends more for participation in the cooperative than it receives in services, said Hoopeston Superintendent Don Dean.

If Danville leaves the association, the group will lose approximately \$140,000, Dean said, adding the cooperative's director has said much of that will be recouped through Danville purchasing individual services from the group.

Hoopeston board member Gary Miller urged Layden to vote for Danville's request. "I'm only envious of Danville if they can get out, from what I've seen of VASE," he said. "I would urge you, Eddie, to let Danville out, but I'll respect your judgment."

Miller said his biggest complaint with the association is it is not "budget conscious. If Danville pulls out, maybe they'll cut staff and not need a new building and all the other things they've wasted money on," he said.

The association is looking for a new building because the current site, purchased within the last few years, is not large enough. "They had to have it but then found out they couldn't use the second floor because it doesn't meet code," Miller said.

Dean agreed with Miller's assessment, saying the group bought the building at 10 p.m. after being

pressured into the purchase. "We probably have the most modern attic that we can't go up to," he said.

Board member Steve Unger asked whether Hoopeston should consider leaving the VASE, but Dean said the district is not large enough to provide all special education services the cooperative provides. "Danville can be captain of their own ship, but the rest of us, there's no way we could do it," he said.

Before Danville can withdraw, the request must be voted on by the VASE board. It will then go to the regional school trustees, the state special education board and finally, the nine-member Illinois State Board of Education, Dean said.
