## City, EPA officials discuss violations, treatment upgrade

A meeting between city officials and the Environmental Protection Agency Tuesday was "very positive," according to a city official.

Alderman Drew Allen, chairman of the city's water/sewer committee, along with Mayor Bob Ault and engineer Larry Johnson, met with five EPA officials in Springfield to discuss minor violations at the wastewater treatment plant.

Tuesday's session came from new regulations regarding infractions, Allen said, adding the city was cited for effluence, or discharge after wastewater treatment and late submission of required reports.

Allen said some infractions were actually typographical errors. "Instead of the reading being .5, it was typed 5.0," Allen said.

Other infractions were "just borderline numbers, actually," Allen said. For example, a problem with the system's aerator caused the rate of ammonia to rise, but not to dangerous levels, he said.

The EPA also questioned the timetable for the wastewater treatment plant upgrade, but "the didn't ask for specifics about when the pipes would be laid or anything like that," Allen said. "All the guy was saying was is (the August completion date) going to be enough time."

New EPA guidelines require that if reports from such plants are over set parameters, the agency in charge of the plant must be cited for that year, Allen said.

Officials are given time to respond in writing, but if the written response does not satisfy EPA officials, a meeting is scheduled. The EPA had originally requested an earlier meeting, but granted an extension because of elections, Allen said.

Further action, including fines, may result after the initial hearing "but this is not anywhere near that," he said.

"You didn't come out of there feeling slapped, you came out feeling like you'd learned something," he said.

A former Vermilion County Board member has been appointed as county recorder of deeds.

Nancy Kelley, a Ridge Farm Republican, was nominated Saturday and approved at Tuesday's Vermilion County Board meeting.

Kelley replaces Judy Myers, who resigned last month to fill the unexpired term of the late Harry "Babe" Woodyard, 53rd District state senator.

Kelley plans to run in November 1998 for the final two years of Myers' term.

In other action, the board awarded two contracts to Newell Construction, Danville, for repairs to the Ross Township Bridge and Grant Township Bridge.

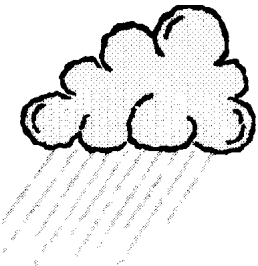
