Residents complain of keeping afloat in sea of water bills

Some Hoopeston residents feel they're drowning in water bills and want to know why.

At Tuesday's city council meetings, residents questioned why they have received water bills, including charges for garbage pick-up, in 21 day cycles.

Mayor Bob Ault explained the city has gone to a new system of calculating bills using hand-held computers. The system, he said, will expedite work for water department employees and will keep bills more current.

Implementing the system means residents will receive two bills in one month, before the cycle returns to normal, he said.

Residents may deduct the trash pick-up fee from the second bill they receive or the amount will be credited on a future bill, Ault said.

It was the second garbage bill that caused concern for

some aldermen. "People said their water bill was lower but they were paying garbage 21 days apart," said Alderman Harold Cox.

Ault stressed that by deducting the second trash bill or receiving a credit in the future, residents would only pay 12 trash charges, not 13.

Alderman John Haughee suggested the change could have been handled better. "It would've been nice if we could've kicked this around before we went through with it," he said. "Aldermen were caught off guard."

In unrelated action, Ron and Barb Knuth, owners of Knuth's Body Shop, requested a change in a newly-implemented vehicle towing policy.

Knuth's, which has provided towing service for the city for 12 years, is now splitting the business with Paul's

The couple object to the change for several reasons, including the fact that Paul's is located in Iroquois County, is further away from the city, and may be under-equipped, under-trained and improperly licensed.

"He don't have the equipment or the know-how," Ron Knuth said. "He may not have an (Illinois Commerce Commission) license."

Kelnhofer could not be reached for comment, but stated earlier that he is properly licensed for towing.

Police chief Carl Valentine decided to alternate months between the two companies, said Sgt. Steve Bane. The change began June 1, he said.

Valentine was not at the meeting.


"Kelnhofer came to the chief and the chief said 'Why should one person monopolize the towing business," Bane said.

Ron Knuth said he does not believe the chief should make the decision. "We wasn't even aware of it until the chief and the other party had it all cut and dried," he said. "I don't think a man from another state has the right to make that decision.

Barb Knuth said the company has had an oral agreement with the city. "I have a copy of that agreement," she said.

Also, she claimed Valentine was rude to her when she asked him about the change. "I was told by the chief that I should stay out of my husband's business," she said. "I own the business with my husband."

Alderman Mark Drollinger, a Vermilion County Sheriff's Department investigator, sided with the Knuths, saying using an out-of-county firm adds "another cog in the evidence chain."

If vehicles are towed to Iroquois County, Drollinger said, officials must deal with another jurisdiction. "Watseka's probably as close as Danville," he said, "but there's a light-year's difference between the courts in Watseka and Danville."

However, Bane said, the police have an agreement with Gossett's Body Shop so vehicles are not towed to Iroquois County.

Bane added the change was not made because of a problem with the Knuths. "As far as the police department itself, we don't have a problem with your service," he said.

The city's police committee will meet at 6 p.m. July 21 to discuss the issue. The Knuths, as well as Kelnhofer, will be invited to attend the meeting.

In other business, Haughee said police will more stringently enforce curfew to cut down on crime.
