## Chief stands by decision to rotate towing business in Hoopeston

Hoopeston's police chief is standing by his decision to rotate police towing calls between two local firms.

"It was an administrative decision," said Chief Carl Valentine. "It's not any big wrongdoing."

Valentine's decision to alternate towing came under fire at Tuesday's Hoopeston city council meeting.

The chief did not attend the meeting at which his decision to rotate towing between Knuth's Body Shop of rural Hoopeston and Paul's Auto and Truck Repair of rural Wellington was discussed.

Ron and Barb Knuth questioned the decision, saving Paul Kelnhofer, owner of Paul's, lives in Iroquois County. The couple also questioned Kelnhofer's equipment and credentials.

Alderman Mark Drollinger, a Vermilion County Sheriff's Department investigator, also questioned the decision, saying using a company from a different county could cause problems if a Hoopeston vehicle were towed to Iroquois County.

Martha L. Miller, 28, of Alvin, was indicted Friday by a Vermilion County grand jury on two counts of solicitation of murder and two counts of solicitation of murder for hire.

Miller is free on 10 percent of \$100,000 bond.

Valentine disagreed with Drollinger's assessment. "He's using an example of something that's never happened in Hoopeston," Valentine said. "In at least 18 years, there's never been a search warrant issued for a vehicle anywhere in Hoopeston."

Valentine said he based his decision on fairness, alternating months between the two companies. Also, the change provides a back-up if one of the companies is unavailable. "It's just good business to have a second towing company," he said

Additionally, residents are asked if they prefer a towing company before officers request the firm on call for that month, he said, and Paul's would not be called for jobs beyond the scope of his equipment. "We wouldn't call him to pull a semi out," he said. "He doesn't have the equipment to handle that."

city's police committee. "I don't feel like this was right, to put it on a political level when they don't even live in the city," he said.

The subject is to be discussed at a police committee meeting at 6 p.m. July 21. Valentine, committee members, the Knuths and Kelnhofer are expected to attend.

Valentine also denied Mrs. Knuth's claim Tuesday that Valentine told her to 'stay out of (her) husband's business.'

"What I said was, with her running down the police

department, she was hurting her husband's business," Valentine said.

"All I was trying to do was be fair, to spread the pie around a little bit" he said. "It has nothing to do with Knuths not doing their job."

Valentine said the issue has been "blown out of proportion," but hopes city officials will back him in his decision. "When I make a decision, I try to make a decision that is best for the city of Hoopeston and the Hoopeston Police Department," he said.

Kelnhofer declined to be interviewed for this story.




