### Pair sentenced in record drug bust

Two Chicago people were senteced last week in connection with a record cocaine bust in February.

Rosaleo Ayala, 31, and Estrella Espinoza, 40, pleaded guilty to criminal drug conspiracy and were each sentenced to 12 years in prison with credit for 176 days each has spent in jail since their arrest.

The two, and a third person, Nabor Lara, 39, of Chicago, were arrested feb. 5 in a raid at 307 N. Sixth St., where police seized 18 ounces of cocaine.

Lara pleaded guilty last week to possession of cocaine and was sentenced to two years of conditional discharge.

A fourth person, Adela Castaneda, was not arrested in the raid, but was later indicted in connection with the raid.

She was found guilty last week of delivery of

cocaine, possession of cocaine, possession of cocaine with the intent to deliver and two counts of criminal drug conspiracy.

Castaneda, scheduled to be sentenced Sept. 12, will face at least 12 years in prison.



# Rossville treasurer requests outside audit to quell allegations

ROSSVILLE—Allegations of missing village funds have prompted the Rossville treasurer to request a special audit.

In a letter to Mayor Merv Smith, treasurer Gene Hughes is requesting the village board approve an outside auditor examine financial records from May 1 through July 31.

The issue will be discussed at a special board meeting at 10 a.m. Aug. 5 at the village office.

The meeting had already been scheduled to discuss the village tar and chip program, but Hughes' request was added to the agenda.

In his letter to Smith, Hughes said his request will likely cause more expense to the village, but said charges of impropriety "reflects on the honesty and integrity of all village officials including myself."

Allegations were raised at the July 21 meeting by Hoopeston attorney Calvin Hultquist, representing trustee William Galloway and approximately 12 other residents.

Hultquist questioned a \$750 difference between a bill

submitted by a Rossville contractor and the corresponding payment and why two copies of the March treasurer's report allegedly exist.

Citing the allegations, Hughes, in his letter, called Galloway's actions at the July 21 meeting "irresponsible and unprofessional conduct in an apparent attempt to sensationalize in the presence of the media and others in attendance at the board meeting."

Hughes further claimed that questions could have been addressed to him before the meeting but were not.

State's attorney Michael Clary said last week that allegations raised by Hultquist and Galloway are being investigated.
