New logo reflects Community Fund past, looks to future


A Hoopeston agency that provides funds for social and recreational groups has changed its label to match its new official name.

Freeman has been one of the driving forces in the village, serving with the Rossville Merchants Association and working to help the Rossville High School Booster Club.

Adwell hopes those Freeman has helped will now in turn help her.

Funds raised "won't be a drop in bucket to what her bills are," Adwell said. "We just want her to know we're thinking of her."
