A draft policy proposal submitted at Monday's Rossville-Alvin school board meeting lists several groups of students and employees who might be tested, said Superintendent Phil Smith.

Groups that could receive random testing include athletes in grades 9-12, student drivers, student machinery operators, extra-curricular participants, administrators and exempt full time employees and staff covered by union contract.

Bus drivers are currently tested under district policy. Should the board approve a random testing policy next month, all groups except employees covered by a union contract could begin testing, Smith said.

Testing of teachers could only begin if testing were approved by the Rossville-Alvin Education Association, he said, adding that issue could be negotiated in the middle of the district's contract with teachers.

Although the district has discussed the idea of student

drug testing for several weeks, staff testing was added at the request of parents.

While the district is discussing a policy, whether one will be approved by the board will not be decided until next month at the earliest. "I think they're leaning toward doing something but I'm not sure," Smith said.


In other action, the board placed the 1997-98 budget on display.

The roughly \$2.8 million budget is "substantially balanced," Smith said. The budget includes expenditures of approximately \$100,000 more than the district will take in. Reserves will make up the difference, if needed, Smith said.

In other action, the board accepted resignations from custodian David Jett, business teacher Jill Byerly Kindred and art teacher Nelson Fertig.


