## City council approves marijuana, paraphernalia ordinance

Hoopeston has strengthened its stand on possession of cannabis and paraphernalia with a new ordinance that will take effect immediately.

The ordinance, passed at Tuesday's city council meeting, will allow police officers to charge offenders with a violation of a city ordinance if they possess under 2.5 grams of cannabis or drug equipment.

The ordinance was the brainchild of Officer Roger Beaty who presented it to Valentine. He, in turn, reviewed the ordinance with Mayor Bob Ault prior to the meeting.

The new law "is sending out a message to anyone 17 and up that they are not going to walk away without a penalty," Valentine said.

Before the ordinance, officers could only confiscate marijuana or paraphernalia and take a chance that the state's attorney's office would file charges, said Investigator James Goodrum.

"There are so many cases of 2.5 grams or less that they never get prosecuted," Valentine said.

Goodrum said that, in more than 12 years, "there's been 100-150 if not a little more, that had either drugs or paraphernalia and nothing could be done."

Estimating the amount of drugs, Goodrum said 2.5 grams is equal to or less than the size of a golf ball, when loosely packed.

Violators convicted under the ordinance may face fines up to \$500. Perhaps more important than the fine is the

# Rossville village board drops gas prices effective Sept. 1

ROSSVILLE—Village residents will pay less for natural gas, thanks to the village board.

The board voted Monday night to lower gas prices by 12 cents per therm, said Mayor Mery Smith.

The decrease will affect all three categories of usage - industrial, school and commercial/residential - Smith said.

The change is retroactive to Sept. 1, Smith said.

While prices were lowered, they may increase again when the temperature drops and the price the village pays for gas increases.

"If it goes up, we'll probably raise (prices)," Smith aid.

Prices may also increase under a plan now being studied by village gas officials which would base the price of gas on its cost to the village, the amount of monthly overhead paid by the village and a fixed profit margin.

Overhead costs run slightly more than \$10,000 monthly, but under the current system, village profits have varied. "This summer, even when costs were down, we only made about one percent profit," Smith said.

In unrelated business, trustees:

□sold a lot at 409 Stewart to Bob Moore for \$3,000.

□approved a temporary zoning change to put a trailer on a lot in the 400 block of McKibben.

Smith said a couple plan to fix up the trailer, then move it.

By ordinance, the trailer must be moved to at least 1.5 miles outside the village limits.

The couple has until Dec. 5 to move the trailer.

fact that officers and citizens will both feel more is being done to fight local drug use. "This is a step in the right direction, because we need all the help we can get," Goodrum said.

In other action, the council approved a \$15,000 revolving loan for Jesse and Diane Zarate.

The couple plan to reopen the Hoopeston Food Locker. The loan will be at 8 percent interest for seven years and is personally guaranteed by a family member.

The business will open once the facility has been inspected by the U.S. Department of Agriculture, Mr. Zarate said. Minor repairs are also needed.

Once open, the food locker will use local stock. The couple plan to hire two to three part time employees, Zarate said.

In other business, the council:

approved a \$91,000 expenditure from Motor Fuel Tax funds for street repairs.

Repairs will include installing handicapped ramps at intersections along Route 9 from South Fifth Ave. to South Fifth St.

Approximately 25 ramps are planned, with the cost to be shared between the city and the Illinois Department of Transportation.
