Trustees lower hook-up fee, considering abolishing real estate tax

ROSSVILLE—"The village of unusual shops" may soon become "the village of lowest payments."

Officials approved lowering utility hook-ups in the village and are considering a plan to end real estate taxes there, as well.

In a 5-1 vote, trustees at Monday's village board meeting approved lowering utility hook-up fees to reflect the cost of materials and labor.

Fees, which range from \$350 to \$380 for gas connections and are about \$300 for water hook-ups, could drop by as much as 60 percent, said village finance committee chairman Tom Mills.

Current rates were set about six years ago, but Mills said he would like to see a "gradual reduction" in rates and hopes more than half the cost will eventually be eliminated.

The change will be implemented immediately, Mills said.

Trustee Jon Witvoet was the sole dissenting vote.

Trustees also discussed eliminating the village real estate tax.

Only five percent of real estate taxes go to the village, Mills said. Last year, that percentage generated \$15,000.

A lower hook-up rate and taxes, combined with water/ sewer and gas rates which, Mills said, are the lowest in a survey of comparably-sized municipalities, would be good for residents and would encourage new people to move to the village, Mills said. "We're going to be able to advertise Rossville."

In other action, trustees:

approved spending \$2,769 for a salt spreader from Roesch Equipment Co., Urbana.

set trick-or-treat hours as 6-8 p.m. Oct. 31.

approved spending not more than \$3,500 for a new business office computer.

tabled a decision on hiring Utility Safety & Design of Edwardsville to provide engineering services for operating the village gas plant.


