Rossville trustees approve 11-member planning committee

ROSSVILLE—A group of local residents has been named to take the village into the 21st century.

Members of the newly-formed Rossville planning committee were approved 5-1 by the village board Monday night.

Committee members are Molly Culbert, Gina Fritz, Dean Grimes, Kevin Kaufman, Brian Laird, Linda Lee, Eva Neeland, Terry Prillaman, Gene Roach, George Shields and Tony Zarate.

The committee's first meeting is tentatively scheduled for 7 p.m. Feb. 2, said Mayor Merv Smith, adding one or two additional members may be added in the future.

The committee's formation came with criticism from some residents.

Resident Abby Yoho questioned Smith regarding who will lead the committee and whether members will be paid.

Smith responded that the group will select a chairman and that members will not be paid.

Yoho questioned what the committee will do, saying the board held little discussion on the issue. "All we've heard is tabled, tabled, tabled," Yoho said. "You said they will serve the village well, (but) doing what?"

Smith replied that residents should attend meetings to learn what the committee will do.

Trustee William Galloway voted against the committee, saying farmers are not represented on the panel and that the village is too small for such a committee.

In other action, trustees officially approved hiring Kristi DeWitt and James Goodrum as part time police officers.

Trustee Chuck Cornell, chairman of the health/safety committee, suggested the action after questions surfaced about whether the two were hired properly. "We're a little bit late in this, aren't we," Galloway asked before the vote. "This makes six police officers we have and they can't patrol the town right." He voted against hiring the officers.

Cornell said Goodrum has worked in the village for about three weeks, while DeWitt, a former auxiliary officer, has been a part time officer for approximately six months.

In unrelated business, trustees learned 22 properties have been identified as needing cleaning or repairs. Of those, 10 owners have been issued warning tickets.

Owners will be given 30 days, instead of the sevenday period mandated by ordinance, to make changes, said Cornell, who displayed dated photographs of the sites.

The time extension was granted because of winter weather conditions.

Owners who make no attempt to clean up their property will be taken to court, Smith said.

In other action, the board:

approved a special use permit for 103 E. Maple. Owner Nancy Dickson plans to open a guest cottage at that address.

Galloway voted against the permit because at a Jan. 8 zoning hearing, one neighbor complained about the change.

Trustee Mick Braddock abstained on the vote but did not give a reason for the abstention.

took under advisement a request from Roberta Spencer of the Rossville Ambulance Service that the board enact an ordinance keeping other ambulances from transporting residents, exempt under mutual aid agreements. Danville man rolls way to top of 88-man field in Budweiser Tournament action Sunday

COVINGTON, IND.—Jason Turner of Danville rolled over 88 bowlers to take Sunday's Budweiser Tournament.

Turner may have set a tournament record 1,009 fourgame set - for a 252 average - on his way to the top.

Action started with a field of 88, 60 on the high side and 28 on the low.

On the low side, Hoopeston's Dave Hughes, #5, battled Jamie Nelson with Hughes winning out by a 189-178 score.

In his second match, Hughes out-dueled Jamie Stevens, 213-150. Match three pitted Hughes against newcomer Andre Brooks, with Brooks withstanding the pressure to win 214-190.

Brooks advanced to battle Wellington's "Hammerin'

Hank" Longfellow, who finished the number one seed. Longfellow won out with a 182-175 score to advance to the finals.

On the high side, two of Danville's finest, Mike McMasters and Charlie Varner, squared in what everyone figured to be a high-scoring battle, with McMasters turning the tables on his team mate, 239-217.

In the second match, McMasters ran into - and over -Michael Seward, 201-183, to face the streaking Chuck Sergent of Hoopeston. McMasters failed to master Sergent, losing 246-224.

Sergent set a showdown with the hottest man on the lanes this day, Turner. Turner showed it was no fluke, beating Sergent 245-191.
