Judicial candidate explains system at watch meeting

The local judicial system and candidates for the March 17 primary were the focus of Monday's Neighborhood Watch meeting in Hoopeston.

Christopher Meyer, Republican candidate for resident circuit judge, listed the current judiciary, including circuit judges and associate circuit judges.

Meyer explained that Vermilion County has six judges based in Vermilion County. Of those, three are circuit judges and three are associate circuit judges.

The circuit judges, currently John O'Rourke, Thomas Fahey and Claudia Anderson, are elected by voters, Meyer said.

Circuit judges may hear a wide range of cases, including civil, felony, juvenile and misdemeanor. Full circuit judges serve six-year terms, he said.

Associate circuit judges are appointed, based on a vote of circuit judges in the area. Associate judges do not

hear felony trials or large civil cases, unless specifically appointed, Meyer said.


Current associate circuit judges are Joseph Skowronski, Gordon Stipp and James Borbely.

In the primary, Meyer is running against fellow Republicans Charles Hall and Robert McIntyre for resident circuit judge, while Vermilion County state's attorney Michael Clary is running on the Democratic ticket.

In separate circuit judge contests, Anderson, a Republican, and Democrat David Ryan are running unopposed.

In a second circuit judge race, involving a position created by an Edgar County judge, Democrat Daniel Brown has no opposition. However, Republicans Thomas Mellen, Fred Kreckman, Daniel Arbogast, James Glenn and Marsha Combs will face off in the




