Hoopeston, Rossville, county slate tire clean up activities

Hoopeston and Rossville, in conjunction with the Vermilion County Recycling program, will host tire clean-ups in August.

The Hoopeston project will run Aug. 3-11, when tires may be taken to the city-owned property on Route 1 across from Arends Implements. The site will be open from 7 a.m. to 3 p.m. Monday through Friday and 9 a.m. to 2 p.m. Saturday.

The city will accept tractor, farm and passenger tires. No tires from retailers or tire dealers will be accepted. Tires on rims or industrial/off-road tires are also banned.

Rossville's collection program will be held Aug. 13. Tires may be taken to the village garage.

The county program will also be held Aug. 13, at Illinois Power, 1155 E. Voorhees, Danville. Collection hours will be 7:30 a.m.-4 p.m.

The county collection has the same restrictions as Hoopeston's. Additional, each person is limited to 1,000 tires and those participating in previous tire collections are ineligible for this collection.

There is no cost to dispose of tires at any of the collection sites. The collections are paid for through the \$1 per tire fee charged to all Illinois residents when they purchase new tires.

Rossville Park District to host sixth basketball shootout

ROSSVILLE—If you can hit nothin' but net, the Rossville Park District has an activity for you.

The sixth annual "Hoop – There It Is!" three-on-three basketball shootout will be held Aug. 8-9 at Christman Park, Rossville.

Official team check-in is Saturday, Aug. 8 from 9-10 a.m. First round preliminary competition begins at 10 a.m.

Teams must register by Aug. 1. Fee for the event is \$45 per three-person team.

The fee entitles each player to the individual free-throw contest, individual 3-point shooting contest, 3-on-3 Shootout entry, and official "Hoop – There It Is" t-shirt.

Contestants for the team shoot-out will be split into men's and women's divisions. Sub-categories in the men's division include junior high (sixth-eighth grade), junior/senior, freshman/sophomore, open 18-34, and

A special parent/child free-throw shooting contest is also scheduled. Entry fee is \$3.

Registration for these events may be made the day of the contest, but pre-registration is preferred.


