Local parishioners not part of John Paul II's U.S. visit

Hoopeston residents will not be among those visiting with Pope John Paul II during his visit to St. Louis Tuesday.

No members of St. Anthony Catholic Church were able to get tickets to any of the pontiff's scheduled activities, said Fr. Terrance O'Brien, pastor of the local Catholic church.

Many tickets were kept within the St. Louis diocese, O'Brian said. Those that were given to the Peoria diocese, of which St. Anthony's is a part, were distributed in a type of lottery, he said. St. Paul's Church in Danville was the closest church to receive tickets.

While no one would be attending the official functions, O'Brien said some local parishioners planned to travel to St. Louis. "But I don't know how that's going to work out," he said.

Earlier, the parish considered sending a busload of the faithful to St. Louis but decided against it. "We're setting ourselves up for maybe some frustration if we were to get a bus together since we can't get into any of the events," O'Brien said.


