### Officer's resignation announced at city council meeting

A long-time Hoopeston Police officer has resigned.

Officer Chuck Moyer's Feb. 3 resignation was announced at Tuesday's Hoopeston City Council meeting by police committee chairman John Haughee.

Moyer, who was with the department approximately 18 years, cited burnout and the desire to find a Monday-Friday day shift job, said Chief Mark Drollinger.

Moyer had been off work since November from a reported job-related injury.

Two on the force have benefited from Moyer's departure.

Officer Jim DeWitt, hired under a federal grant, was offered and accepted a full-time position, Drollinger said.

The police commission will consider applicants and hire a new officer under the grant, which expires in 2001. Drollinger hopes the commission finds a candidate already trained. "I'd like to get somebody with experience," he said. "Sending someone to (the Police Training Institute) eats a considerable amount of time."

Also, Officer Darin Tate, who has served as interim investigator during Moyer's recuperating time, has been appointed to the investigator's position. In the near future, he will work with the Vermilion County Sheriff's Department investigation unit to receive additional training, Drollinger said.

### Council revisits Sunday sales for New Year's Eve 2000

An exception allowing alcohol sales in Hoopeston on Sunday, Dec. 31, 2000 will stand but the vote, taken at the Feb. 1 meeting, would have been different had two absent council members been present.

At Tuesday's meeting, city attorney Jim Spiros said by ordinance, the 4-2 vote was not official until Mayor Bob Ault voted on the issue. Ault voted with the majority to allow the exception.

However, two council members not at the Feb. 1 meeting, said they would have voted against the variance.

"I think that it sends a bad message to the community," said Alderwoman Susan Comstock. "Just a year ago, we said there would be no sales on Sunday, no exceptions." Because there was no committee meeting to discuss the change, "no one had the opportunity to discuss it," she said.

Alderman Rod Kaag said he would have voted against the exception as well, but favors changing the ordinance to allow total Sunday sales or for special occasions.

Under the change, bars may be open 3 p.m. Dec. 31 until 1 a.m. Jan. 1, 2001.

In other action, the council:

- approved Dan Goodrum and Kebbie Knake as planning commission members.
- approved spending \$81,500 on a used 1991 jet-vac truck for the city. The city had \$118,000 set aside to replace a 1975 model said Alderman Drew Allen.

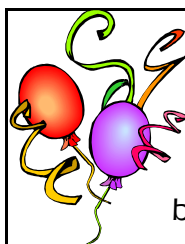
