Hoopeston City Council approves 23-year TIF plan

Hoopeston officials may begin courting developers to implement their tax increment financing (TIF) plan.

In 7-1 votes, the city council approved the 23-year TIF plan and project, the proposed area and adopted the tax increment financing tax ordinance. Alderman Drew Allen was the lone dissenting vote.

Approval means the city may now seek out developers to work on improving residential, commercial and industrial areas of the district.

One area planned for residential growth is currently farmland east of Euclid. It is not within the city limits but Mayor Bob Ault said the owner sent a letter stating the property would be annexed once TIF was approved.

In unrelated action, the council:

- will go forward in trying to find a company to manage the ambulance service. The ambulance committee met last week with PRO Ambulance representatives; Arrow Ambulance has asked to submit a proposal, as has Hoopeston Community Memorial Hospital, Ault said.
- approved yield signs on East Elm and Lincoln at Sixth and Seventh streets and will post "no U-turn" signs downtown.
- learned it will cost \$85,000-\$100,000 to fill in 600 to 700 feet of a ditch from Sixth Ave. to Route 9.
- heard concerns from Bill Orr about plans to resurface Fourth St.

DANVILLE—Hoopeston attorney Paul Manion has defeated incumbent Larry Mills as the Democratic candidate for Vermilion County State's Attorney.

With 57 of 64 county precincts reporting, Manion received 1,818 votes, compared with 1,038 for Mills. In Danville voting, Manion received 1,281 votes compared to Mills' 940.

Young in the November election. Young, who ran unopposed, received a total of 5,295 votes in the county and Danville.

In the race for Vermilion County Circuit Clerk, Susan Ponder Miller defeated Democratic challenger Brenda Bostic, 2,780 to 2,427.

Miller will face Republican candidate Leigh Busby Hughes, who received 5,045 votes running unopposed.

In the coroner's contest, Bruce Stark defeated Nina Finchum for the Democrats. Stark received 2,704 votes compared with 2,284 for Finchum.

Stark will face incumbent Peggy Johnson who received 5,199 votes.

In the race for 115th Congressional district representative, Democrat Lauren Prussing led Mike Kelleher 2,518 to 2,482 in Vermilion County voting. On the Republican side, Tim Johnson lead the four-man field with 3,364, followed by 1,432 for Brady, 147 for Jones and 1,257 for Ewing.
