## **Investigators look into emotional state of PSB shooter**

DANVILLE—Police are investigating the mental state of a man who drove his vehicle into the Public Safety Building Wednesday before firing a gun.

The Vermilion County Sheriff's Department has subpoenaed the medical and psychological records of Stanley G. Shank, 59, of Tilton.

On Sept. 13, Shank drove his Jeep Grand Cherokee up the PSB steps, then fired a handgun. Shank was killed when three Danville police officers returned fire.

Shank believed the CIA had implanted some sort of chip in his brain, that police had been peeking in his windows and that he was a federal agent and that he "had a desire to kill people," said sheriff's department Chief Investigator Gary Miller. "Obviously, he built up some sort of hostility towards police," Miller said.

Shank had no contact with police as far as being arrested and had one contact as a victim from a burglary approximately two years ago, Miller said.

The day of the shooting, Shank "talked to his vehicle for about 30 minutes, got upset and sped away," Miller said, adding the time frame matches with the time of the shooting at about 12:35 p.m.

Shank had two guns with him Wednesday, the one he shot in the Public Safety Building and a second in the Jeep. The .357 Magnums had been purchased within 10 days of the incident, Miller said.

Investigators are checking with Illinois State Police to see whether Shank, who had a valid Firearm Owners Identification card, ever had such a card revoked.

As the investigation continues into Shank's actions, the return fire has been declared justified. "The investigation showed the police officers' actions and use of deadly force was necessary for their own protection and that of civilians (including employees and two bystanders in the Public Safety Building lobby)," Miller said.

Results of the investigation were given to Vermilion County State's Attorney Larry Mills, who ruled the shooting was lawful.

"I would say they acted properly and courageously," Miller said.
