### Revolving loan fund money goes to lagoon aeration project

A program used to establish businesses in Hoopeston will be without funds for a little while.

Approximately \$60,000 in the city's revolving loan fund will be used to help pay the costs of a new aeration system at the lagoons, a condition of receiving a \$500,000 Department of Commerce and Community Affairs grant for the aeration system.

The Hoopeston City Council on Tuesday approved using the revolving loan funds and okayed other aspects of grant participation.

The revolving loan program funds business start-ups or improvements, with owners able to borrow \$10,000 for each full-time equivalent position created.

Using the money towards the lagoon project will temporarily decimate the fund. Although the project will benefit Hoopeston Foods, whose wastewater is treated at the lagoon, the company will not have to repay the revolving loan fund, said Alderman Kevin Davis, water/ sewer committee chairman. The city may apply for more DCCA funds for the loan program and payments made on existing loans can be loaned to future borrow-

Davis is enthusiastic about the aeration project. "I truly believe this has a good chance of eliminating the odor," he said. "I'm excited about it.

In related action, the council waived approved Bowen Engineering Corp. of Fishers, Ind., to complete the project pending engineering approval from Dailey & Associates. Four construction bids were received, with Bowen being the only one at or below the project estimate, Davis said.

The city must complete the project to meet a Dec. 1 deadline set by the Illinois EPA to rectify the odor problem. Davis said.

## Computer crimes get attention from regional task forces

Criminals using computers to commit their crimes are the focus of special task forces and Hoopeston is represented in one of those groups.

Russell Rudd, dispatch supervisor for the Hoopeston Police Department, spoke about the Regional Computer Crimes Enforcement Group at Monday's Hoopeston Neighborhood Watch meeting.

Rudd is Hoopeston's liaison to the group.

Vermilion County is in the Mid State region, which also includes Iroquois and Champaign counties, among others, Rudd said. In all, the area task force includes 15 members of local law enforcement agencies, including the Vermilion County Sheriff's Department, represented by Rod Kaag of Hoopeston.

The group's function is to help local law enforcement deal with computer crimes, such as child pornography and computerized fraud through such things as on line auctions, Rudd said.

Members of the group must receive 80 hours of training which was set up by the Illinois Attorney General's Office. The group is made up of people who use computers and who are "fine tuning their skills," Rudd said, adding the group recently completed first-level training.

The training teaches task force members to extract evidence from computers without tampering with it. "We take a snapshot of everything that's there," Rudd said. By using specialized equipment to copy what is on a computer, rather than removing computer parts, "defense attorneys can't claim we manipulated evidence. It's worked extremely well in

other parts of the stat so far."

Presenting evidence to suspects often means the suspects will avoid lengthy trials. "Ninety nine times out of 100, they just plead guilty because the evidence is there in front of them," he said.

Computer crimes are becoming more prolific although few have been reported in Hoopeston. Hoopeston Police Chief Mark Drollinger said two local cases involving computers are pending, including a fraud case involving a woman who received money for auction items but did not send the items to buyers. Drollinger said the woman was serving a jail sentence and was unable to send out the items in a timely manner.

The other case, still under investigation, involves a man who, using a fictitious email account, told a victim of a crime the man had committed against the victim. That incident is still under investigation, Drollinger said.
