On Jan. 15, the board voted 4-2 not to allow a zoning ordinance amendment that would create a special use permit allowing a fire station to be built in an R-1 residential area. The current board on Friday held a public hearing to gather the opinions of residents.

Hoopeston attorney William Nelson, representing Mr. and Mrs. Ed Perkins and Jim Smith, was the first to speak, and said the hearing was not part of the village's procedures and should not go forward. He then outlined the history of the case, starting two years ago when the Rossville Fire Protection District requested a zoning change on approximately three acres on the east side of Chicago St. on the north edge of the village.

After the board's Jan. 15 vote, the fire district took the matter to court, filing suit against the board. The issue,

Several residents spoke in favor of a new fire station. Some agreed with the planned location; others had no opinion. Most agreed the fire station should be kept in village limits, providing a higher fire rating and lower insurance costs for residents.

Prillaman suggested the issue was being blown out of proportion. He reminded residents of the war in Afghanistan, the bombings of the World Trade Center and Pentagon and the plane that crashed in Pennsylvania "and here we are sitting here fighting over a fire station," he said. "100 feet one way or the other isn't going to make much difference." he said.

The Rossville Village Board is expected to discuss the issue at its meeting at 7 p.m. Monday. The meeting will be held in the village office and is open to the public.

and that he did not want to have weddings and other social events held directly north of his home. During the course of the imbroglio, Perkins has tried to sell his home but a potential buyer refused to purchase the home until the issue is settled. "I can't even sell the house and get out," he said. "I'm just trying to protect my property and my rights."

Asked whether he will continue litigation, Perkins said that answer depends on whether the village accepts a compromise proposal.

Nelson said his clients offered the solution of moving the proposed fire station one acre north of suggested location. Not only would this separate the station from homes but it would also solve a potential drainage problem and provide easier access from Rt. 1.

That land is not part of the village but falls within 1.5 miles which would give the village zoning control, said Mayor Terry Prillaman.

The property is currently not for sale but Prillaman said someone suggested earlier Friday that the fire district take the land by eminent domain, getting a site for their fire station and reducing the cost involved in the project.
