New county program offers second chance to drug offenders

A six-month-old Vermilion County program is helping addicts kick drugs and lives of crime.

Drug Court, established last October, offers county residents a chance to get clean, said Vermilion County Circuit Judge Michael Clary.

Clary was the featured speaker at Monday's Hoopeston Neighborhood Watch program.

The program is limited to non-violent felony offenders. It is not designed for first-time offenders, but instead is for those who not only abuse drugs or alcohol but have committed crimes such as retail theft, Clary said.

Offenders interested in participating in Drug

Court must first be screened by a Treatment Alternatives for Secure Communities (TASC) representative who recommends whether someone should be admitted.

Once admitted to the program, offenders receive counseling at Prairie Center in Danville anywhere from one to three times weekly, must attend Narcotics Anonymous or Alcoholics Anonymous meetings and receive drug screenings every Monday prior to weekly appearances in Wednesday Drug Court. pants also are placed on felony probation, 12 months in Drug Court probation and 12 in regular probation and meet with a probation officer from once a week to daily, depending on the circumstances.

while it was in the 800 block of West Main.

Finding work is another facet of the program. Clary said Drug Court is trying to get help from the Department of Rehabilitation Services to not only find jobs for participants but also to teach them job skills.

The Vermilion County State's Attorney's office and public defenders' office are also involved in the program.

To take advantage of the program, offenders must voluntarily give up some of their Constitutional rights, Clary said. For example, if a participant has a positive drug test, there is an immediate punishment: jail time. "It doesn't wait for 60 to 90 days down the road," he said. And if participants don't succeed, "they're going to the Department of Corrections. This is not a slap on the wrist, soft on crime program."

Officials are not the only ones who think Drug Court is not an easy program. Clary talked about a participant in his middle 40s who has used drugs for 30 years. "He's told us on the team that it's easier to go to the penitentiary and do his time," he said.

Some participants need more intense counseling than is available at Prairie Center and must be sent to a residential facility. Since most facilities have waiting lists, participants either struggle through at home, or like an earlier participant, ask to be kept in jail until a spot is found, Clary said. Two participants are now waiting in jail until openings are available, he said.

The county Drug Court program began with four participants; currently 10 are enrolled. With existing resources, Clary said 25 is the maximum number of people who can use the program.

A former state's attorney, Clary said he saw the same faces before him in court. When he heard about Drug Court, Clary thought the program might break the cycle.

Drug Court is a national program that began about 10 years ago in Louisville, Ky., as a "long term solution to a long term problem," Clary said. It has since spread nationwide and has been endorsed by the National Sheriffs Association and the supreme courts of all 50 states.
