## Sheriff's police seek assistance in death of man on bicycle

DANVILLE—The Vermilion County Sheriff's Department is asking the public for information on the death of a Jamesburg man Friday.

Michael Lee Fink, 20, was killed apparently as he was riding a bicycle eastbound on Jamesburg Road and was struck from behind by a car.

An inquest will be held at a later date to determine the exact cause of death.

Sheriff's police responded to a call about a body lying along the road. The accident occurred sometime after midnight. Fink was pronounced dead at the scene at 3:30 a.m.

Police confirm the vehicle was a 1986-1990 Chevrolet Celebrity. The vehicle should be missing the end portion of the driver's side bumper, which is silver or grey. The car may be silver or grey but that is not a certainty.

## Rossville-Alvin school district hires interim superintendent

ROSSVILLE—Rossville-Alvin officials have hired an interim superintendent to oversee district schools until a permanent replacement is found.

Timothy Musgrave, former superintendent of the Bismarck-Henning district, was named interim superintendent effective July 1. Musgrave will work three to four half-days each week.

Musgrave retired from the Bismarck-Henning district two years ago after having served 19 years in the district.

He replaces Phil Smith, who resigned effective June 30 to become superintendent of the Momence district north of Kankakee. He began his new job there July 1.

The Rossville-Alvin board will continue to look for a permanent replacement for Smith. The district is using the Illinois Association of School Boards to head up the search for a replacement.

Applications must be turned in by Monday. According to reports, 13 applications have already been received but about 20 are expected.

After the deadline passes, Rossville-Alvin officials

will select two area active or retired superintendents to review applications with an official from the Illinois Association of School Boards. That committee will recommend which candidates should be interviewed.

Officials hope to have the winnowing process completed by the board's July 15 meeting so the board may decide whom to interview. Initial interviews are expected to begin the following week, followed by second interviews and visits to the village.

The board hopes to have a new superintendent in place by Aug. 19. Musgrave will work as superintendent until that time.
