Voters to decide fate of Vermilion County's nursing home

Voters will be asked to determine what the Vermilion County Board should do with Vermilion Manor Nursing Home.

At Tuesday's meeting the board voted to put the fate of the nursing home on the November 2 ballot. Voters will be asked two questions, said District 1 representative Gary Weinard: are taxpayers willing to pay an additional tax of one-tenth of one percent to fund the nursing home and are taxpayers willing to let the board sell the nursing home.

The vote, 18-4 in favor of putting the issue to voters was "a very strong bi-partisan vote on an issue," Weinard said.

Weinard, along with other local representatives Chris Leigh and Mark Drollinger, favor getting the county out of the nursing home business because of the drain it causes on county finances. While the budget shows Vermilion Manor runs in the black, once capital improvements, FICA, employee insurance and other payments are deducted, the facility has run in the red for 10 of the last 14 years. Last year, Vermilion Manor lost about

\$350,000, he said. In 2002, the loss was about \$430,000.

The suggested tax would add about \$33 to the tax bill on a \$100,000 house. The total collected would be "just about what the shortfall is right now" but would not cover losses from increased costs in the next few years. Weinard said.

If voters allow the board to sell Vermilion Manor, the board should be able to divest itself of the responsibility fairly quickly. Weinard said nursing home companies regularly approach the county about purchasing or leasing the facility. "If we can do that, then we can turn our attention to things we can't put in the hands of the private sector" like animal control and mental health, he said.

Money saved on funding the nursing home could be used in other areas, such as providing employee raises. Some workers have changed job classifications but haven't been given raises to go along with them because of a shortage in funds, caused in part by the county funding the nursing home, Weinard said.

Vermilion Manor started in the 1860s as the county poor farm. In the 1930s or 40s, it became a nursing home.

Weinard, a proponent of selling the home for some time, credits county board chairman Bill Boyer with bringing the issue to the table. "It's finally come to the point where everybody thought 'we've wrestled around with this and we think we've put it to bed and then we wrestle with it again.""

"I don't count it so much a victory or personal satisfaction but we're now at the point where the voters will have a say in this thing," he said. "That's all I've ever wanted."
