

Rossville Village Board puts teeth into vicious dog ordinance

ROSSVILLE—Owners of vicious dogs in the village will have a bite taken out of their wallets following Monday night's Rossville Village Board meeting.

The board approved amending its animal ordinances to include higher fines for owners of dogs deemed vicious. "The new one gives us some teeth in it," said

Under the existing ordinance, violators of dog ordinances were fined \$25. The amendment increases to \$150 the fines for owners of vicious dogs, defined as animals that, when unprovoked, bites or otherwise attacks a human or other animal on public or private property or when the owner of a dog known to be dangerous is found to be in violation of the ordinance on two sepa-

rate occasions.

The board also discussed dropping coverage by Vermilion County Animal Control and its \$2,000 annual fee. "It doesn't seem like they do that much," said trustee Tom Gregory.

Prillaman responded that budget cuts at the county level have decreased services and that not having a dog catcher in the village causes many problems. "When you eliminated the dog catcher, you opened up a can of works like you haven't seen before," he said, adding that the village paid the former dog catcher more in mileage than it pays now to the county.

Hoopeston Area step closer to co-op baseball with Rossville

Hoopeston Area school board is expected to vote in June on whether to co-op middle school baseball with Rossville-Alvin.

At Thursday night's Hoopeston Area School Board meeting, high school Principal Hank Hornbeck outlined the program, which would be open only to Hoopeston Area eighth graders. Hornbeck said 19 eighth grade students were interested in playing but that if seventh graders were also included, it would "give us way too many kids," with a potential for 40 young athletes between Hoopeston Area and Rossville-Alvin, a number too unwieldy with the team's no-cut policy.

The proposed two-year agreement calls for Hoopeston Area to pay for an assistant coach.

In unrelated action, the board unanimously approved a new computer system for managing student data.

Two proposals were reviewed, one from MMS, whose system the district currently uses, and Software Technology, Inc.

The MMS system "only with great difficulty can han-

dle the new requirements that the state forced on us," said Superintendent Mark Conolly. STI's web-based system allows latitude "now but well into the future."

Board member Larry Jahn said the existing system is DOS-based and has been used for about 15 years. MMS's use in the state is limited while STI is in more than 500 districts.


Officials hope the transition on the \$30,490 system will be completed over the summer.

In other action, the board:

• Approved resignations from grade school art teacher Donna Brown, who is retiring, along with speech/ language pathologist Katie Clayton; Honeywell learning disabilities teacher Emily Jones; Mike Caparula, high school drama director; middle school cheerleading sponsor Donna Hiltz and Lisa Miller, middle school personal aide.

• Approved hiring Jeff Ohlemeyer as high/middle school dean of students.

better than none at all. "I don't think we want to be without it with the situation the way it is now," she said. In related discussion, residents who do not allow access to meters for village utilities may be fined \$150, if a new ordinance is approved.

Residents have gone to lengths to keep employees from reading gas and water meters, including keeping dogs tied close to the meter and parking vehicles over the meters, Prillaman said.

Trustee Mark Catron suggested giving residents a verbal warning before issuing a citation but Prillaman asked "why? They know it has to be read."

The issue was referred to the gas committee.

In unrelated discussion, trustees said burn barrels will be included in items picked up during townwide cleanup June 10. Residents who are able are asked to put barrels in front of their homes to be picked up. Those who are unable to do so are asked to call the village office to make arrangements for barrels to be removed by June 14.

Trustees also:

• Moved forward on foreclosing on 113 Maple. If successful, a structure on the property will be demolished and the property sold. The vote was 4-1, with Gregory being the sole dissenter, saying the issue is "something I don't think we need to get into doing."

• Reappointed Cathy Brooks and Phyllis Bell to the
