Ag department sets meeting on claims against Kaufman Grain

SPRINGFIELD—The Illinois Department of Agriculture has scheduled a creditors meeting to explain the liquidation and claims process for Kaufman Grain Company, a defunct Vermilion County elevator operator.

The meeting will be held at 7 p.m. Tuesday, May 8, in the Rossville-Alvin High School gym, 350 N. Chicago. It is open to anyone with a financial interest in the company's grain holdings, including producers who currently have grain stored in one of Kaufman's elevators or who have not been paid for grain sold to the company.

The Illinois Department of Agriculture assumed con-

trol of Kaufman Grain's facilities in Rossville Rankin and East Lynn on Thursday, April 26, after the company voluntarily surrendered its Illinois Grain Dealer's and Illinois Grain Warehouse licenses. Department examiners are still assessing Kaufman's ability to pay claims protected under the Illinois Grain Insurance Code, but believe its grain assets are sufficient to pay outstanding obligations.

Kaufman Grain Company was a member of the Illinois Grain Insurance Fund and all grain deposits at its facilities are protected under the Illinois Grain Code. Grain in storage is covered at 100 percent of its close-out value as determined by the department. Grain that was priced within 21 days of the date of failure is also covered at 100 percent, while grain held under a price later contract is protected at 85 percent of the close-out value based on the length of time since delivery and pricing.

Health Department begins checking birds for West Nile

With the approach of warmer weather, the Vermilion County Health Department is beginning its surveillance efforts to identify the presence of West Nile virus in the community by collecting dead birds for testing. "Finding out early if the virus is present in Vermilion County allows us to alert residents to take precautions when they are outside and make sure their homes are free of places where mosquitoes breed," said Environmental Health Director Kolby Riggle.

Dead birds are collected locally, then sent to the state laboratory to determine if they may have been bitten by infected mosquitoes. Positive results may mean the virus is present in a community. The Vermilion County

Health Department will accept a limited number of dead birds, including crows, blue jays, grackles, starlings, sparrows, finches, robins, cardinals, flycatchers, swallows, catbirds, mockingbirds, warblers, and wrens.

Riggle said not all birds will be accepted for testing. "The state will only accept a small number for testing, and we have to send them good samples," Riggle said. He added, 'The larger birds are preferred because they provide more tissue for testing." Birds submitted to the health department for testing

should show no obvious cause of death, should not be in a state of decomposition, and should not have been attacked by animals.

A mosquito infected with West Nile virus can spread the disease by biting humans. The virus was first noted in Illinois in the summer of 2001. By 2002, the Illinois Department of Public Health reported over 800 human cases of West Nile in Illinois. In 2006, Riggle said, there was one human case of West Nile reported in Vermilion County.

The state health department said most people are

not affected when bitten by a West Nile-infected mosquito, but some people, including those who are over age 50 and who may have chronic health problems are most at risk from the West Nile virus.
