### One man caught, second sought in Iroquois Fed burglary

One man is in custody and a second in is being sought in connection with a burglary early Monday morning at Iroquois Federal Savings & Loan.

Joshua M. Tofari, 18, of 259 Locust, Chebanse, was being held at the Public Safety Building, Danville, on preliminary charges of burglary, possession of burglary tools, resisting arrest and criminal damage to property over \$300 in connection with the incident.

Tofari is expected to be arraigned Tuesday in Vermilion County Circuit Court. Monday was a county holiday and the courthouse was closed.

Police said officers were called to Iroquois Federal at

2:15 a.m. Monday for a report of someone possibly trying to break in to the ATM machine. When officers arrived, a man fled to the south. Tofari was apprehended

The second man wanted in connection with the incident may be in custody in Iroquois County.

An unnamed man was arrested near Milford at about 4 a.m. for possession of a controlled substance, said Lt. Randy Eimen of the Iroquois Sheriff's Department.

That man, related to Tofari and also from Chebanse, is believed to have been an accomplice at the Iroquois Federal incident.

This is the second time since August that Iroquois

### Hoopeston changes dog policy based on vet's office closing

Hoopeston officials are scrambling to find a solution to dogs running loose after the local veterinarian's office closed.

Officials were notified that Hoopeston Family Pet Care would no longer shelter strays picked up by the city, effective Friday. "We're scrambling to find out something to do," said Alderman Ed Lotz.

As police committee chairman, Lotz oversees animal control issues.

"I've instructed the animal control officer to not pick up any animals until there's a solution," Lotz said. "It's a major situation for us."

Police officers will deal with vicious animals, Lotz said, adding officers have previously been called in for such animals.

The city has some options, such as contracting with Vermilion County animal control. Some communities, such as Rossville, contract with the county for animal
