

# Woman gets probation, must repay \$7,240 taken from city

A Hoopeston woman was sentenced to two years' probation on charges that she stole money while a city employee.

Elena Smith, 28, who listed an address in the 800 block of East Main, was sentenced Thursday in Vermilion County Circuit Court.

Judge Claudia Anderson sentenced Smith to 24 months probation. Under terms of the agreement. Smith must also repay \$7,240 over five years at \$120 per month.

Smith, a former Hoopeston Water Department clerk, was charged in April with one count of theft over \$300-\$10,000. That count was later dismissed and she was charged with official misconduct in connection with offenses on September 1, 2004 and December 31, 2006.

She pleaded guilty to that charge in return for receiving probation.

I am not in the medical field, and I know little about how the industry works. I can imagine, though, that there are several aspects of the career that are crucial to successful patient care. I would assume that doctors are evaluated on things like careful and complete charting and coding, continuing education, speed and accuracy of diagnosis, demonstration that appropriate tests and labs are ordered based on symptoms, punctuality, performance under pressure, and bedside manner, as well as patient feedback, all go into a doctor's performance. Do the nurses and other doctors at the hospital have full awareness of all these aspects (and all the other important ones to which I am not privy) of the performance of any one doctor? Again, I can only draw the conclusion that the matter is best left to the professionals like Dr. Timmons whose work in our community has been proven repeatedly, and not to upset nay-sayers.

Finally, the petition that has been passed about is essentially meaningless to me. It is already established that the doctors at the hospital, including Dr. Kuha, are gen-

erally good physicians. Again, they may very well be nice men. They have all had their share of successes, and for that, we should all be grateful. But what is the petition supposed to prove? If there were a petition in support of Dr. Timmons with 200 signatures on it, would that make his case stronger? And, is employment at a hospital a matter of democratic vote? I am relieved that it is not. That petition was signed by well meaning people who, again, lack the tools to make an adequately informed decision. Did any board members sign the petition?

I support Dr. Timmons because of how he has improved the reputation and quality of care at the hospital. In my view, things in the ER are much improved in the last few years because of Dr. Timmons's group. Because I wish to have the very best care close to home, and Dr. Timmons has afforded me that provision, he will continue to receive my support, trust, and business.
