Clothing collection for cancer questionable

Having a daughter with cancer, I have become well aware of the many reputable national and local organizations that depend on monetary donations to fund cancer research and to assist families during their struggle with cancer.

Quite recently, I noticed a clothing collection bin in the parking lot at the corner of Rts. 1 & 9 in Hoopeston. The bin solicits clothing and shoe donations for an organization called 'Cancer-Free America Foundation Inc.' This organization distributes clothing collection bins throughout several states and leads donors to believe that the donations will benefit cancer research and families of cancer patients in local areas.

Interested in this cause, I found myself searching the internet for information on 'Cancer-Free America Foundation Inc.' What I found was alarming. If you are donating your clothing and shoes with the thought that all of the proceeds of your goods or even a reasonable portion of the proceeds will be used toward cancer research or to assist local families, you are being scammed.

Clothing and shoes collected are sold for-profit and only a very small portion of the proceeds collected are ever given to charities. It appears that the rest of the money goes to the organization's founder, Jay Katari from Boca Raton, FL who operates several of these collection bin foundations under impressive-sounding names.

Even more alarming, I found no record of this foundation listing as a legitimate charity or business with the Better Business Bureau. I also could find no financial disclosure information detailing charitable contributions from 'Cancer-Free America Foundation Inc.' What I did find were numerous complaints, news reports and articles discussing the misleading nature of this organization and its founder, Jay Katari.

The organization does have a website (www.clothingforthecure.com) with very vague information touting the benefits of the collection bins. They are free to communities. They help keep your town free of clutter. They encourage recycling. Local hospitals will receive grants from the proceeds.

Searching the website further, it is easy to notice major critical omissions. For example, there is no disclosure of which local organizations receive funds or what percentage of the money is actually donated back to communities.

I am alarmed that Hoopeston has ended up with a bin and individuals are bringing clothing by the bagful to drop off with the idea that they are in some way helping to 'fund cancer research.'

I find this organization's misleading tactics especially insulting given the fact that our community has proven to be sensitive and supportive to the families in Hoopeston who are dealing with cancer. I feel as though this organization is taking advantage of our generous and charitable community members.

More importantly, 'Cancer-Free America Foundation Inc.' is essentially 'stealing' donations from other reputable organizations within Vermilion county - organizations that are struggling to help our communities during
