Hoopeston Regional Health Center is currently recruiting to fill one or more ER Tech/EMT-I/B positions. The hours for the positions are 1:00 PM to 9:30 PM with some weekends required.

The positions will normally be located in the Emergency Room and will function as an ER Tech in that setting. The ER Tech positions will assist the ER Nurse in the care of Emergency Room patients. Duties may include taking vitals, performing EKG's, starting IV's and other care as directed by the Nurse.

The position would perform as an EMT – I/B with the Ambulance Department when patient care needs require it. This position is responsible for assessing the nature and extent of injury or illness to establish and prioritize medical procedures to be followed. The position administers life support care to the sick and/or injured patients in a pre-hospital setting as authorized and directed by the Physician.

Qualified candidates will have a current Illinois EMT-I or EMT-B license. The position requires excellent communication, customer service and clinical skills.

Hoopeston man charged with four counts of murder

Calloway held without bond in murder of Kelly Wright

A Hoopeston man is being held without bond in connection with the death of a Hoopeston woman December 30, 2009.

Brandyn R. Calloway, 24, who listed an address of 812 E. Elm, is charged with first degree murder-great bodily harm, first degree murder, intent to kill, first degree murder-knowing death, and first degree murder-strong probability, all Class M offenses, in the death of 27-year-old Kelly L. Wright, of Hoopeston.

Calloway, who was being held without bond prior to his court appearance, pleaded not guilty to all charges at an arraignment Thursday. Judge Gordon Stipp continued the order for him to be held without bond.

According to a joint press release from Hoopeston Police Department and Vermilion County Sheriff's Department, police received a 9-1-1 call at 8:49 a.m. Wednesday to the 500 block of South Fifth St., for a woman who was nonresponsive in a home. Police and ambulance personnel responded, where they found Ms. Wright's body.

Autopsy results showed Ms. Wright died of multiple stab wounds to the upper body, according to Vermilion County Coroner Peggy Johnson.

According to reports, Ms. Wright was visiting a friend's home when the incident occurred. Ms. Wright and Calloway were allegedly in a dating relationship.

Calloway is no stranger to the legal system. At 18, he was found guilty of criminal sexual abuse with a 16-year-old girl, according to state sex offender information. In 2004, he was charged with failure to register as a sex offender and was sentenced to 165 days in the Public Safety Building, with credit for 165 days served, as well as 30 days' probation.

In 2007, he was charged with possession of a controlled substance and was sentenced to 30 months' probation.

Funeral services for Ms. Wright will be held at 11 a.m. Tuesday at Segur-Knapp Funeral Home, Watseka. Visitation will be one hour prior to service at the funeral home.

The daughter of Samuel Wright and Rossann (Simonton) Hammond, Ms. Wright is survived by her mother, of Sheldon; a son, Dylan Shoulders and a daughter, Samantha Shoulders, both of Hoopeston; and sisters Amanda Hammond of Wellington and Kimberly Hammond of Sheldon.
