## High school door security system policy to start August 19

An entry security system at Hoopeston Area High School will become effective on August 19. High school principal Larry Maynard presented information at Thursday's school board meeting on how students and visitors may access the building.

Doors will open at 7:50 a.m. on school days, with entry only through the main office (east) doors. At 8:20 a.m., doors will be locked.

Students who have athletic, band, chorus or other early morning activity will have to be let in by the coach/sponsor. Doors are not to be propped open for any reason.

Visitors to the school must push the A-Phone to be let in during the school day.

In other business, the board approved a \$106,223 bid for property/casualty and Worker Compensation insurance from Doug Farder with Workers' Compensation Self-Insurance Trust.

The bid was one of four received, including \$120,417 from Harris Agency/Indiana Insurance; \$117,074 from McMurray Agency/Selective Insurance; and \$108,671 from PCIS.

In discussing the bids, board member Larry Jahn said the savings could be used for other school expenses.

In unrelated business, the board:

- Approved resignations of Melissa Huckleby and Jennifer Wagoner, Honeywell aides; and Eugene Warner, assistant football coach.
- Approved Evelyn Dain's retirement as middle/high school lunchroom cashier.
- Hired Joanne Knowles, middle/high school English; Matt Daniel, assistant football coach; and John Zollar, head varsity volleyball coach.
- Approved transferring Clint Mathewson from JV girls basketball to head varsity girls basketball; Eric

Zorns from middle school girls basketball to high school JV girls basketball coach; and Brock Baker from paid high school football assistant to volunteer assistant.

- Reinstated Diana Judy, middle school Title aide and Annette McMillan, high school personal aide. Both are non-tenured.
- Approved all certified and non-certified salary agreements for the 2010-11 school year.
- Received copies of student handbooks from principals. The only major change is the additional of infectious disease procedures.
- Heard from transportation director Mark Eighner that no new buses will be purchased this year to hold down costs.
- Approved board members Lisa Leigh, Mark Schaumburg and Larry Jahn each earning up to \$2,000 annually from the school district.
