Local man in federal court on child exploitation charges

URBANA-A Rossville man who formerly worked as a youth pastor made his initial appearance in federal court Monday afternoon on charges of sexual exploitation of children.

Andrew I. Thomas, 46, was charged in a five-count indictment returned by a grand jury last week but sealed pending his appearance in court, announced U.S. Attorney James A. Lewis, Central District of Illinois.

Thomas appeared before U.S. Magistrate Judge David G. Bernthal and was ordered to remain in the custody of the U.S. Marshals Service pending trial, which is scheduled on Nov. 29, before Chief U.S. District Judge Michael P. McCuskey.

Each count of the indictment alleges that Thomas, a former youth minister at First Church of Christ in Rossville, enticed minors to engage in sexually explicit conduct to produce images of the conduct.

According to the indictment, Thomas is also known as: "Stephanie Danielson," "Kayla Wilson," "Jennifer Martinez," Jessica Gonzalez," "Justin Danielson" and, "Justin Williams," and used the email addresses: justjock89@aim.com, Kaylaw21to@aol.com, Foryouhopeulike@aol.com, Luknfrmystudboy2@aim.com, Stephaniedanielson89@hotmail.com, and stephaniedanielson1989@yahoo.com."

During Monday's court appearance, the government requested that Thomas be detained in federal law enforcement custody pending trial. According to court documents filed by the government, Thomas allegedly perpetrated a scheme to disguise himself as a female identified as "Stephanie," "Jenn," "Jessica," or "Kayla" through social networking sites, e-mail accounts and text messages using a Trac phone to make contact with minor-age boys. Thomas then allegedly covertly enticed the minors, by sending them pornographic images of his female personae, to solicit pornographic images of the

minor boys. The indictment alleges the time of the alleged conduct as follows: count one - from February to March 2010; count two - January to March 2010; count three - January 2007 to January 2010; count four - December 2009 to March 2010; and, count five - January to March 2010.

Rossville officials raise nuisance fees; woman requests reimbursement of \$176 towing, storage fee after charge dismissed

ROSSVILLE—Minutes after the village board approved raising the fee for nuisance fee violations, an Iroquois County woman requested a refund for a towing and storage charge from such a violation.

Trustees on Monday approved increasing the fee from \$300 to \$500 for nuisance violations. The amendment to the ordinance, approved by the health and safety committee, passed by a 4-2 vote, with trustees Tia Petersen and Dennis Barragree voting against.

Shortly after that action, Sherry Decker requested a refund of \$176 for towing and storage she paid on behalf of a young acquaintance who was ticketed for loud music.

Decker told the board the man was ticketed on a state charge, to which he pleaded guilty, but an accompanying village ordinance violation was dismissed after the com-

Decker was reimbursed for the \$300 fee but not the towing and storage charge that resulted from it.

Trustee Nancy Null said the "righteous ticket" was issued but the witness was unable to appear but Decker maintained that after the young man apologized to the witness, the woman did not want him to face the fees associated with the violation.

Admitting the young man made a bad choice, Decker said everyone has made bad choices. "It's like you're trying to add to the village coffers. I think that's a problem. If you want to sit and discuss it later, that's fine but I think you owe me \$176."
