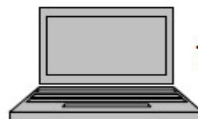

## USPS: area post offices among 3,700 that may be shuttered

The U.S. Postal Service is looking to downsize and will study approximately 3,700 offices, including some in the local area, to determine whether they will remain open.

The list of offices which may be on the chopping block include Alvin, Armstrong, Collison, Indianola and Muncie in Vermilion County. Iroquois County offices include Claytonville, Iroquois, Stockland, Vermilion, Wellington and Woodland. The post office in Ambia, Ind., is also on the list.

According to a postal service website, the cuts are necessary because more customers are conducting postal and other shopping business online.

“Today, more than 35 percent of the Postal Service’s retail revenue comes from expanded access locations such as grocery stores, drug stores, office supply stores,

retail chains, self-service kiosks, ATMs and usps.com, open 24/7,” said PMG Pat Donahoe. “Our customer’s habits have made it clear that they no longer require a physical Post Office to conduct most of their postal business.”

USPS is introducing the Village Post Office as a potential replacement for communities that currently do not have a post office and those whose offices will be shuttered. Village Post Offices would be operated by local businesses, such as pharmacies, grocery stores or other retailers, and would offer popular postal products and services, such as stamps and flat-rate packaging.

“The Postal Service of the future will be smaller, leaner and more competitive, and it will continue to drive commerce, serve communities and deliver value,” said Donahoe.
