Middle school registration will be held from 8:30-11 a.m. and 12:30-3:30 p.m. August 9 and 8:30-11 a.m. and 1-6 p.m. August 10.

Registration for Early Childhood Special Education and grades K-sixth will be held August 10 at the middle school. Hours will be 1-6 p.m.

Special registration assistance will be available to migrant families on August 10 at the Migrant Education table.

Freshman orientation, for students and families of incoming freshmen, will be held at 6 p.m. Thursday, Aug. 11.
