Crusinberry, Dobkins discuss issues at mayoral forum

Hoopeston's incumbent mayor suggested residents get a say in what new services the city provides while the man challenging him thinks ways can be found to cut money from the budget.

Mayor Bill Crusinberry and challenger Jeramy Dobkins told voters their plans for Hoopeston at a public forum Monday night. The event, sponsored by The Chronicle, drew more than 50 people to the Hoopeston American Legion.

After several questions about dilapidated and abandoned buildings in the city - with Crusinberry saying the city has no funds to tear them down and Dobkins suggesting city employees be used - Crusinberry said he will ask the council for permission to put the issue before voters at a future general election, asking for a sales tax hike to fund demolition in Hoopeston. The first \$50,000 raised would go towards razing homes, with the next \$25,000 going towards demolition of commercial buildings. Any money left over would go to the city's accrual fund for vehicles and major equipment.

Resident Claudia DeWitt, who started by questioning abandoned buildings, said such a tax would "fall on the backs of seniors," but Crusinberry said seniors constitute a large voting bloc and could defeat a referendum. tra money to tear these buildings down," he said.

Another point between the candidates is whether city employees can take on more tasks, such as maintenance and repairs to city vehicles, sidewalk repairs and others.

Dobkins said workers could do such tasks, saying the cit pays too much for some projects that call for the city to pay prevailing wages.

Prevailing wages are set by regulatory agencies and must be paid on projects paid, at least in part, by state or federal money. The rate varies from trade to trade but is usually significantly higher than the wage paid to city employees.

Crusinberry countered that Hoopeston has a sufficient workforce for city needs but not the extra employees it house from 2-4 p.m. Saturday at Hoopeston American Legion. 502 E. Penn. would take to do additional projects. Because Hoopeston cannot afford to fully fund large projects, the city accepts federal/state money and must abide by the prevailing wage law.

Crusinberry outlined accomplishments, including the new McDonald's, nursing home, Autumn Fields, Prairie Meadows, new water main, and plans for a second term which include refurbishing the aerial and ground water storage tanks; updating the sand filters at the water treatment plant and keeping city finances in the black.

Dobkins praised what Crusinberry has done but said he wants to make sure the city is solid so the children and grandchildren of his generation "would be proud to call Hoopeston their home."

Law regarding political signs

Some political signs are placed incorrectly around Hoopeston and need to be moved. The ordinance states that political signs shall be confined to private property, and shall be removed within 14 days after the election for which they were erected. In areas where no sidewalk is available, Office Manager Loni Gress said it is from the power pole to the street, so signs may be placed between the power pole and the house, or the sidewalk and the house.




