### Hoopeston to participate in state debt recovery program

If you owe Hoopeston money - whether from a water bill, court fees or mowing charge - Illinois is going to help make sure you pay.

Hoopeston will take part in the state's debt recovery program, offered by the comptroller's office. Those who owe and work for the state may have wages garnished, while others may find their state tax refund lowered to accommodate the debt. On top of the original debt, administrative fees are added to the repayment, making the program free to the city.

It was announced at Tuesday's Hoopeston City Council meeting that Hoopeston court clerk Greg Lane will administer the program assisted by Marta Pierce, water department clerk.

In other business, Leander Construction of Canton was the low bidder to refurbish Hoopeston's ground and aerial water storage tanks, with a bid of \$2,048,400, said Mike Streff, engineer with Foth Infrastructure and Environment. Leander's bid was \$500 higher but company officials found an error that lowered the total by \$500, Streff said.

A second bid, for \$2,262,000, was submitted by Thieneman Construction of Indiana.

### EPA asks leave ash alone

The US EPA is requesting that residents refrain from picking up ash in their yards until testing of this ash has been completed and the results of the testing are released. The winning bid was "a little bit higher than we thought it would be last fall," Streff said.

During the project, residents can expect to see changes in the water, including more rust, said Alderman Bill McElhaney, water/sewer committee chairman, who suggested residents purchase home filtration systems as an inexpensive solution.

In other business, the council:

• Learned some improvements have been made at the swimming pool, including new shower doors on the women's side, and adjustments to the autofeeder for chemicals, said Alderman Carl Ankenbrand, parks committee chairman.

• Approved a \$33,774 bid from Ribbe Trucking for roads at Floral Hill. Work is expected to be completed by August 15, said Alderwoman Nancy Stipp, cemetery committee chairman.

• Heard a complaint from resident Brenda Pancake about J&R Tire Recycling on Route 9. "It seems like they're thumbing their nose at the city," she said.

• Mayor Bill Crusinberry said he would arrange a meeting with company officials to work out a solution to the amount of tires and shredded tires stored outside.

school board and Hoopeston Education Association.

The new contract was achieved with only 1.5 days of negotiating, said Supt. Hank Hornbeck, who thanked the union for their willingness to work with the district.

Base salary will increase to \$29,825 for a beginning teacher. Additional pay is given for longevity and continuing education, as well as for additional assignments, such as coaching a sport or sponsoring groups like the spelling or Scholastic bowl teams.

In other personnel matters, the board:

• approved resignations from Annette McMillan, high school personal aide, and Cayla Knight, middle school personal aide, at the end of the school year; April Handy, high school student council co-sponsor, effective May 23; and Dawn Samet, Maple classroom aide, effective May 29.


• Approved transferring Rhonda Carter to middle school classroom aide for the 2-13-14 year.

• Approved Logan Patton as high school head wrestling and assistant football coach; and Thomas Sage, high school assistant Scholastic Bowl coach.

In unrelated business, the board approved delay of the No Pass/No Play policy pending a student intervention program, which is expected to include tutoring.
