# County health department names new administrator

Jenny Trimmell has been named Public Health Administrator of the Vermilion County Health Department following Shirley Hicks' retirement on March 3.

"I look forward to working with the Board of Health and our community partners in making this a safe and healthy community," said Trimmell.

Trimmel will serve as administrator following the retirement of Hicks, who started working for the health department in 1985 and who has served as administrator since June, 2010.

Trimmell started working at the health department in 1997 as the Health Educator. She then spent a year as an Education Specialist at Carle Clinic in Urbana, but returned to the health department in 2001 as a staff nurse for the Family Planning/STD program.

# Barickman focuses on day budget was to be released

SPRINGFIELD—Illinois taxpayers have seen it before - Gov. Quinn and his legislative majorities wait until after an election to reveal a plan to raise taxes and increase spending.

Highlighting the day the Governor was to unveil his budget plan, State Senator Jason Barickman (R-Bloomington) joined his Republican colleagues in calling on Governor Quinn to share his budget plans with the public now, rather than waiting until after the primary election.

By law, Quinn was to release his annual budget plan Feb. 19 - but was given a reprieve when Democrats pushed through a deadline extension earlier in February.

"Everyone knows this will be a difficult budget year. We have a lot of work ahead of us to balance the budget. The sooner we can get that process going, the better," Barickman said.

Keeping the budget plans under wrap until after an

election is reminiscent of the last governor's race, Barickman said, pointing out that after the 2010 election Democrats approved and Ouinn signed the largest tax hike in Illinois history. That tax hike passed in the middle-of-the-night during a lame-duck legislative session.

Barickman said the delay in releasing the budget is just one concern.

"We need to adopt policies that will reverse job losses, bring spending under control and prevent ever-higher tax increases," Barickman said. "That is going to require bipartisan cooperation that is made more difficult by the Governor's political decision to keep his budget under wraps."

Barickman said the state's unemployment rate, which is the third highest in the nation, along with Illinois' status as the state with the worst credit rating in the nation, means Illinois must focus first of turning around

Barickman said several steps should be taken to move the state forward and show good faith on the part of the Governor and his legislative allies.

#### **Enable Economic Growth**

•Roll back the 2011 income tax increase as promised and required by law;

- Take the progressive income tax a job-killing tax hike -off the table:
- •Enact a "primary causation" standard in workers' compensation to build on 2011 reforms and bring Illinois' employer costs closer to those of neighboring states;
- •Work with Republicans to develop long-range, sustainable economic development programs.

#### **Control Spending**

- •Bring state spending in line with revenues;
- Prohibit the creation of new programs and expansion of existing programs;
