VCSWCD sets cover crop events at Hoopeston, Oakwood areas on September 5, 10

Vermilion County Soil and Water Conservation District and ProHarvest Seeds are cosponsoring a cover crop demonstration plot from 9-11 a.m. Friday, Sept. 5. The event will be held on the farm ground of Dave Olson, southwest of Hoopeston (field location: T23N-R12W Sec. 20 W Grant Twp, 1130 East Road).

On display at the cover crop demo plot will be different cover crop species and mixes, as well as different planting methods and dates. Come investigate particular species' growth habits, planting done by a Case 5400 no-till drill vs a Kinze planter with 15 inch rows, etc.

Staff from ProHarvest Seeds will be available to answer questions and discuss important considerations for cover crop establishment and management. Mills Ag Services will have information on aerial application services. Also, SWCD and NRCS staff will be on hand to discuss technical assistance and government program opportunities.

Light refreshments will be served.

The second event will be from 1-3 p.m. September 10 when VCSWCD and American Farmland Trust cosponsor a cover crop demonstration on the farm ground of Kevin Green along I-74, approximately two miles west of the Oakwood exit (along CR 680 E).

On display this fall and next spring will be 25 acres of cereal rye planted into standing corn and 25 acres of Tillage Radish®/oats planted into standing soybeans.

Both fields will be seeded with the use of a Hagie® Cover Crop Interseeder unit, operated by FullThrottle Ag Services in Roberts.

Also 10 acres of cereal rve will be drilled with a Great Plains no-till drill after harvest to examine fall and spring growth using drill establishment.

See the Hagie® Interseeder unit in action, ask questions of FullThrottle Ag Services and learn more about another cover crop establishment technique.

No tickets or injuries were reported in an accident at 2:33 p.m. Saturday at South Sixth Ave. and West Elm.


