**New USDA tool provides conservation information online**  
 DANVILLE—The U.S. Department of Agriculture's new online option, Conservation Client Gateway, allows individual landowners and land users the secure ability to request conservation technical and financial assistance from the USDA Natural Resources Conservation Service. District Conservationist Adam Wyant at the Vermilion County office encourages local farmers to look into what this new tool has to offer.  
 "Conservation Client Gateway will save Illinois farmers time and money by not having to drive to our office every time they need a map or I need a signature on something," Wyant said.  
 Producers can log on to the website and request technical assistance, schedule appointments or field visits, apply for conservation program assistance, review and sign documents, and access conservation plans, maps and other files. The online service options are only available for individual farmers and landowners at this time. NRCS will offer these services for farm entities, as well as smartphone options in the future.

## Former resident hired as Georgia Southern assistant coach

STATESBORO, Ga. – Georgia Southern Head Women's Basketball Coach Kip Drown announced the completion of his coaching staff. Drown hired two new assistant coaches and kept Lisa Jackson from the previous staff.

Joining Jackson on the staff are former Georgia Tech captain and Toledo Assistant Coach Alex Stewart and Georgia College Assistant Coach [Toby Wagoner](#).

"I feel really good about them, and I like them as people. I feel like we have good chemistry," Drown said. "Recruiting wise I feel that we are very well connected in Georgia, and I told them in our staff meeting that there should not be a kid that leaves here that could play here that we are not at least in on. We might not get them, but we should know about them."

Wagoner joined the Eagles after five seasons as an assistant coach at Georgia College and spent the 2009-10 season as a graduate assistant for the men's basketball team. He helped the Bobcats to a Peach Belt Conference championship game appearance and a 16-13 record in 2014-15 and a tournament championship in 2010-11.

"He has great contacts with the high schools in the state of Georgia. Georgia College's team camp has grown to where it is probably the largest team camp in the state. He was dealing with hundreds of high school coaches across the state and is very connected there," Drown said. "He brings some things defensively that are close to what I believe, and I think we will be able to learn from his system and the system that I have used and coordinate those two together."
