Ezra Elliott wins sectionals, headed to state this week

Freshman wrestler Ezra Elliott represented Hoopeston Area High School well Saturday, placing first in the Olympia Sectionals at Stanford

The win earned the grappler a trip to state finals, which will be held February 18-20 at State Farm Center in Champaign.

Elliott's journey started with a win at regionals, giving him a bye in first round competition at last weekend's sectionals. In his first match, Elliott defeated Andrew Sims, of Heyward, with a 14-7 decision. He then faced Joe Burris, of Petersburg, with a technical fall in 5:05.

In his final regional match, Elliott defeated Vincent Rink, of Herscher, with a 10-5 decision.

In his first match at state, Elliott will face Trae Blaser, with a 34-14 record, from Aledo in Mercer County.

Other Hoopeston Area wrestlers at Saturday's regionals included:

● Dale Ashby (37-9), who received a bye in the first round, then faced Zach Wilson, of Macomb, in the 152 lb. quarter finals. Ashby lost in a 7-2 decision, then went on to defeat Austin McWethy, of El Paso, by fall in

Ian McGraw, of Knoxville, was Ashby's next challenger in the next consolation round, scoring a 14-9 major decision.

Ashby finally fell to Key-Shawn Girkin, of Gibson City-Melvin Sibley, in the consolation semifinals after losing a tie-breaker decision.
